DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame house is located on Dorsey Hotel Road approximately one mile north of U.S. Route 40. The house faces east. It is a two story, four bay by two bay structure with a gable roof. A story-and a-half one bay by one bay addition is located at the gable end of the north elevation. A two story shed addition covers the rear, west, elevation. A porch supported by aluminum posts and balustrades covers the facade. Entrances are located at the center of the facade and rear elevations.

An exterior cinderblock chimney is located at the north elevation of the rear addition. The house is lit predominately by two over two sash windows framed with plain flat boards. One over one sash windows are located in the gable ends of the main block and six pane windows are located in the half story of the rear addition. The house rests on a stone foundation. The cellar is entered from beneath the facade porch. Asbestos shingles cover the house with asphalt shingles on the roof.


