DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame farmhouse is situated in a hilly area on Dorsey Hotel Road approximately 2 miles north of Grantsville and Rt. 40. The house faces east. It is a two-story, three-bay-long structure with a gable roof. A single story shed addition, open as a porch at the north end, runs across the facade. A single story shed addition, open as a porch in the center, extends across the rear, west, elevation. A single story, two-bay by two-bay frame structure with a gable roof and an interior gable end brick chimney is located at the south end of the facade. The house is entered from the facade porch.

The house has an exterior brick gable end chimney at the north elevation. 2/2 sash windows light the house on the first story, with 6/3 sash windows in the second story. Plain flat boards frame the windows. The house rests on a cinderblock foundation. Asbestos shingles cover the exterior with corrugated metal on the roof. In the center of the roof is a bird house.


