The Wilburn House, located at 20 Railroad Street, Jennings MD is not located in a historic district nor is it considered eligible for individual listing on the National Register of Historic Places.

The Wilburn House is a two-story "I" house, three bays wide, with a common pitched roof, probably built between 1900 and 1930, following the development of the Jennings Brothers Railroad in the early 1900s. The Wilburn House was noted as a non-contributing element in the survey district. The entire structure is covered in asphalt shingles. The property has undergone extensive alterations to include the two-story rear addition. According to earlier survey photographs the house originally had a central chimney, which has been removed. There is now a modern chimney at one of the gable ends. The property has a one-story front porch with a shed roof, with a gablet, two turned and two plain posts and one end of the porch is enclosed by a wall. The windows are two over two and the front door is in the center of the principal façade.

The dwelling is typical of domestic architecture of the period and lacks the architectural distinctiveness to qualify it for listing on the National Register of Historic Places under Criterion C. The property is not known to have any associations with persons or events significant to our past and is thus not eligible under Criteria A or B.


