## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The John Teets House is located on the SW side of White Rock Road, approximately .2 miles NW of its intersection with Trap Run Road. The house stands in a small clearing.

The house is a one and  $\frac{1}{2}$ -story, gable-roofed dwelling with a three-bay, center-door facade. The facade points NE. The SE gable end measures two bays while the NW elevation measures one bay across. A one-story, shed porch runs the length of the facade, and a one-story, shed-roofed addition runs the length of the rear (SW) elevation.

The house rests on a low stone foundation and the plank-constructed walls are covered with brown brick-patterned asphalt siding. The windows are two over two sash except on the second floor of the SW elevation, where they are two panes set side by side. All windows have simple cornices and plain board surrounds. The central facade door has two glass panels.

The roof is covered with asphalt roll siding over asphalt shingle. The house has one interior chimney at the center of the house. The porch roof is covered with asphalt roll siding and is supported by four square wood posts.

The interior of the house is unknown.


