DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Joseph Lewis House is located on Cranesville Road, about one mile NW of Swallow Falls State Forest. South of the house are several modern vacation cottages and Muddy Creek.

The house is a two-story, gable-roofed, T-plan dwelling with a three-bay, center-door facade. The side elevations of the main block measure two bays, and the T two bays by one. The facade points N. A one-story, hipped-roof porch covers the facade and a one-story, glassed-in porch with a hipped roof fills in the T on the S and E elevations. On the W elevation the ground drops sharply and a spring emerges from under the foundation wall of the S elevation of the main block. The water runs S and a plank footbridge has been built over the spring hollow.

The house rests on a low cut stone foundation and the stud-constructed walls are covered with grey asbestos shingles. The windows are one over one sash and have no trim. On the facade the E and W bays on both floors contain coupled windows. In the gable ends the attic windows are two over two sash.

The roof is covered with asphalt shingles and the box cornice returns on the gable ends. The house has one interior chimney in the T. Both porch roofs are covered with asphalt shingles and supported by turned posts which sport jigsaw brackets. The rear porch has been enclosed with glass panels in wood frames.

Southwest of the house are two frame garages, both covered with board and batten siding.


