DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Sang Run Open Door Chapel is located on the south side of Sang Run Road approximately .6 miles NE of the Youghiogheny River. The church sits in a small clearing surrounded by woods.

The chapel is a one-story, gable-roofed, rectangular structure with a gable-end facade. The facade points NW. The side elevations measure four bays long. The facade door has a gable-roofed hood.

The chapel rests on a low dressed stone foundation and is covered with white-painted German siding with a wooden water table. The church has cornerboards with simple pilaster caps and above the string course on the gable ends the walls are shingled with square wood shingles with trimmed corners. The windows are four over four sash with simple cornices and plain board surrounds. On the SE ("east") elevation is a single round window divided into quarters. The entrance has double doors and stone steps. The hood roof is covered with asphalt shingles.

The roof is covered with asphalt shingles and has a box cornice. The church has a small square bell tower at the NW gable end; its pointed cap was recently blown off in a high wind.

The interior is unknown.


