DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame store, gas station, and residence is situated just northeast of Swallow Falls and faces south. It is a three-bay by two-bay, two-story building with a gable end facade. A single-story shed addition is located on the west elevation of the structure, and a two-story, two-bay wing with a gable roof abuts the east elevation. A shed porch runs along the facade of the structure and is enclosed on the gable wing.

An interior, brick chimney is located at the west elevation. 2/2 sash windows light the house on the facade and west elevation. 3/1 sash windows appear on the east wing and on the rear of the building. Plain flat boards frame the windows.

The structure rests on a stone foundation. The gable end, block and shed addition are covered with asphalt shingles, the east wing with asbestos shingles, and the roofs with tar paper. The gable end block can be entered by a central entrance. The east wing has a central facade entrance. The west shed addition also has a facade entrance.


