DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame farmhouse is situated in a hilly, wooded area just northeast of Swallow Falls and faces southwest. It is a two story, three by one bay structure with an ell, two bays deep, off the northeast elevation. A 1-story hipped roof enclosed porch runs across the facade and wraps around the southeast elevation as an open porch. The house has a central entrance.

A cinderblock chimney is located at the rear end of the ell. One over one sash windows light the house with the exception of a large picture window on the first story, northwest elevation. Three over one sash windows light the enclosed facade porch. Plain flat boards frame the windows. The house rests on a stone foundation. All elevations of the structure are covered with asphalt siding as is the roof.


