## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame house is situated in a hilly wooded area just north-east of Ginseng Hill and faces east. It is a two story, three by two bay structure with a one bay by one bay story-and-a-half ell. The house has a gable roof. A porch, supported by chamfered wooden posts with jig-sawn brackets, runs across the facade and around along the south elevation of the house. The entrance is centrally located on the facade. A second entrance appears on the south elevation of the main structure.

Interior brick end chimneys appear on the main structure with an additional exterior brick chimney on the south elevation of the ell. The house is lit by one over one windows with six pane windows in the gable ends of both the main structure and the addition. Double windows appear on the first story on the facade's south side, the east side of the south elevation and on the rear of the ell addition. The house is covered with asbestos shingles. The roof is covered by both scalloped and square slate shingles.


