DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame farmhouse is situated in a hilly area just east of Bishop Hill and faces east. It is a two story, three by one bay structure with a two by one bay ell. The roofs are gabled. A porch, supported by four plain square wooden posts, extends over the facade bays. A porch, in an L shape, runs across the rear west elevation of the house and the interior south elevation of the ell. Entrances appear on the facade of the house and at the rear.

A central brick chimney is located on the house. Two over two windows light the structure. A cellar entrance appears on the east elevation. The house rests on a stone foundation. Aluminum siding covers the facade and sides of the house with asphalt shingles on the rear. Asphalt shingles cover the roof.




