DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Nathaniel Frazee Farm is located on the Friendsville-Hoyes Road, immediately S of Elder School (G-III-A-007), and 3.3 miles S of Friendsville. The ground slopes down E of the site to woodland. The farm consists of a house, barn, and several frame outbuildings.

The house is a two-story, gable-roofed, ell-plan dwelling with a three-bay, center-door facade. The facade points SW. A one-story, one-bay entrance porch covers the facade door and a one-story shed-roofed porch covers the NW elevation of the ell and part of the same elevation of the main block. The ell is filled on the NE and SE elevations by two one-story, shed-roofed additions.

The house rests on a cut stone foundation and is covered with moulded-bevel novelty siding with water table. Most windows are two over two sash; however, the windows on the second floor of the facade are three over one sash and in the ell on the NW elevation is a picture window. In the shed-roofed additions, one over one sash windows and two paned windows set side by side are also represented. All windows have simple cornices and plain board surrounds. All trim is painted green.

The roof is covered with standing seam metal. The house has two chimneys: an interior brick chimney on the NE elevation of the main block between the main block and the ell addition, and an exterior stone chimney on the NE elevation at the junction of the ell and the ell addition.

The gable roof of the facade porch is covered with tar paper and supported by four chamfered posts. The shed roof of the porch on the NW elevation is similarly covered and supported. Both porches have balustrades of turned posts.

The yard is enclosed to the NW, SW, and SE by a low stone wall. The interior of the house is unknown.

East of the house is a small frame outbuilding with a gable roof. NW of the house is a frame bank barn covered with vertical boards. The barn has a gable roof. Other frame outbuildings are scattered near the barn.


