DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The John Schlosnagle Farm is located on the W side of Brethern Church Road, approx. a mile and a half SE of Accident. The farm consists of a house, barn and several outbuildings.

The house is a two-story, gable-roofed dwelling with a three-bay, center-door facade. The facade points SE and its first floor is covered with a hipped-roofed sunporch. The rear (NW elevation) is covered with a one-story addition.

The house rests on a cut stone foundation and is covered with German siding over which has been placed asbestos shingle. The windows are two over two sash with plain mitred surrounds. The facade door has a transom.

The roof is covered with asphalt shingles. The house has two brick stove chimneys; one interior chimney at the N corner of the main block and one exterior chimney at the NE end of the NW elevation of the main block. The sunporch is enclosed with one over one sash windows and its roof is covered with asphalt shingles. The interior arrangement of the house is unknown.

N of the house is a one-story, gable-roofed structure now used for storage but originally possible a summer kitchen. The structure is covered with German siding and is roofed with corrugated metal. The structure has doors on its NE and Sw elevations and a nine-light window on its SE elevation.

N of this structure is a chickenhouse. E of the house, across Brethern Church Road, are a frame bank barn, a garage and a corn crib. The barn rests on a concrete block foundation and is covered with vertical boards.
