DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Earl Beitzel House is located on the E side of Accident-Bittinger Road, across from Aiken-Miller Road. The house is surrounded by trees.

The house is a two-story, gable-roofed, ell-plan dwelling with a three-bay facade. The facade points W and is covered with a one-story, shed-roofed porch. The ell is filled with a catslide wing.

The house rests on a stone foundation and is covered with white German siding. The windows are one over one and two over two sash with plain mitred surrounds. The facade door is placed in the southermost bay and has a single pane of glass with an etched scene of a windmill set into it.

The roof is covered with corrugated metal and has a facade cross gable. The box cornice returns on the gable ends. The house has two stove chimneys: an exterior cinderblock chimney on the N gable end and an interior brick chimney at the center of the ell. The facade porch roof is covered with asphalt shingles and is supported by turned posts with jigsawn brackets. The interior arrangement of the house is unknown.

SE of the house are two small, frame, gable-roofed outbuildings and to the N of the house are several gable-roofed frame farm buildings.

STATEMENT OF SIGNIFICANCE

This house is an example of a common western Maryland type. Houses of this general configuration, a rectangular main block and rear kitchen wing, were constructed in Garrett County from the late nineteenth through the early twentieth centuries. This house was built by a locally prominent carpenter of the time.
