DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The David O. Dewitt House stands on the N side of a curve in Hoyes-Sang Run Road. About a quarter mile N of its intersection with Hoyes Road. The house stands on rising ground and is backed by fields.

The house is a two-story, gable-roofed, T-plan dwelling with a three-bay, center-door facade. The facade points S and is covered by a one-story, shed-roofed porch which also covers the E elevation. On the E elevation the T has been filled with a two-story addition, while on the W a one-story addition fills the T.

The house rests on a coursed stone foundation and is covered with aluminum siding over German siding. The German siding is exposed under the facade porch. The windows are one over one sash and under the facade porch show original drip mouldings and board surrounds. Elsewhere the surrounds have been obscured.

The roof is covered with asphalt shingles as are the roofs of the facade porch and the additions. The house has one exterior brick stove chimney on the N gable end. The porch roof is supported by round wooden columns on brick pedestals and the porch has a turned balustrade. The interior of the house displays an enclosed central staircase. NW of the house is a frame, gable-roofed bank barn.

STATEMENT OF SIGNIFICANCE

This house is an example of a common western Maryland type. Houses of this general configuration, a rectangular main block and rear kitchen wing, were constructed in Garrett County from the late nineteenth through the early twentieth centuries. The house was constructed by the parents of the current owner on land which has been in the Dewitt family since 1854. David Dewitt tore down a log house to build this dwelling.


