DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame farmhouse is situated in a hilly area of Rt. 495 approx. 1½ miles north of North Glade Road. The house faces east. It is a two-story, three-bay by one-bay structure with a gable roof. A single story shed addition extends across the rear, west, elevation. Another single-story addition is located off the side, south, elevation.

A wooden porch, supported by plain square wood posts, extends the length of the facade and the south elevation to the addition. The house has a central facade entrance.

The house is lit predominantly with 1/1 sash windows (2/2 sash windows are located on the first story facade). Plain flat boards with drip cap molding window heads surround the windows.

The facade of the house and the south elevation addition are covered with narrow German siding with cornerboards. Asphalt shingles cover the side, north, and south elevations, with shingles in the gable ends. The rear addition is covered with aluminum siding. Asphalt shingles cover the roof.


