The John Beachy House is a two story, three-bay by two-bay gable roof structure with a gable end facade and a two-bay by two-bay ell extending from the center of the rear, north, elevation.

The house rests on what appears to be a poured concrete or concrete-covered foundation.

A two-story, three-bay by one-bay German sided frame structure is located to the west of the house. This structure once was a blacksmith shop.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame farmhouse is located in a hilly area at the corner of Rt. 495 and Beachy Road. The house faces south. It is a two story, three-bay by two-bay gable roof structure with a gable end facade and a two-bay by two-bay ell extending from the center of the rear, north, elevation. Single story shed additions, with entrances, are located along the east and west elevations of the ell.

A wooden porch, supported by turned and knobbed posts with jigsaw brackets, covers the facade bays. The central facade entrance has a transom.

An interior brick chimney is located at the gable end of the west elevation of the main block, a cinderblock one to the east elevation. 1/1 sash windows light the house. The cellar is entered at ground level from the east elevation.

Asphalt shingles cover the house and the roof.

The house rests on what appears to be a poured concrete or concrete-covered foundation.

A two story, three-bay by one-bay German-sided frame structure is located to the west of the house. Above the central entrance is a loft entrance. 6/6 sash windows light this structure that once was a blacksmith shop.


