DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Red Ridge Farm is located .9 mile west of Westernport Road, off Red Hill Road. The house is situated in a hollow on the southeast side of Red Ridge approximately 1.2 miles south of New Germany. The site includes a dwelling and privy, and the ruins of a frame barn and outbuilding.

The house is a frame, two story, gable-roofed building on a stone foundation. Its basic configuration is an ell-plan consisting of a three bay by one bay main block and a one bay rear wing. The facade, which points southwest has its windows spaced irregularly and has two doors that occupy the central and southern bays. A shed-roofed porch shelters the rear (northeast side) of the main block.

The foundation that the building rests on is whitewashed, coursed and roughly squared stone. German siding covers a layer of vertical plank. It is uncertain whether this plank is the actual support structure or merely a covering for a frame system. Six over six sash windows, with some one over one replacements, light the building on all elevations. Additionally, a small, rectangular window pierces each gable end. The two facade doors and the two rear doors are raised, four-panel. The roof is covered with corrugated metal and has a brick stove chimney located at the center of the ridgeline on the main block. The cornice consists of a fascia board and another board wedged in at an angle in the space between the rafter ends and the wall. A basement entrance is located on the northeast side of the main block.

The barn ruins are located south of the house. Its foundation, still intact, is composed of coursed, rubble stone topped by hewn sills. The floor joists are unhewn logs and the supporting posts are machine sawn. Vertical board siding covered the building.

A frame privy and the ruins of a frame, gable-roofed outbuilding lie between the house and barn.


