DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Thomas Murphy farmhouse is a two-by-one-bay, gable roofed structure with a two bay ell on the back. On the southeast facade, an enclosed shed addition appears to have once been a porch.

On the southwest side of the ell is a second entrance with a bracketed gabled overdoor. The windows are three-over-one double hung sash. The house is presently covered by aluminum "German siding."

Included on the property are numerous outbuildings only a few of which were built prior to 1940. Just outside the side entrance to the house is a single story ceramic block springhouse. Also to the southwest side of the house is a plank outbuilding. Many other buildings of various periods are present including a chicken house and a barn built in 1940.


