DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame farmhouse is situated in a hilly, semi-wooded area on Meadow Mountain Road. The house faces Southeast. It is a two story, three-bay by one-bay gable roof structure with an ell.

A single story, two-bay by one-bay addition is located at the northeast elevation. A wooden porch supported by plain square posts extends the length of the facade. The house can be entered from the central facade entrance, the northeast elevation of the northeast addition, and from the southwest elevation of the ell.

An exterior cinderblock chimney is located just east of the northeast gable end. An exterior brick chimney is located at the northwest elevation of the ell.

2/2 sash windows are located in the facade and 1/1 sash windows in the side elevations. Single pane windows appear in the gable ends. Plain flat boards frame the windows.

The cellar is entered from the northeast elevation of the enclosed area under the facade porch.

The exterior is covered with shingles. Asphalt shingles cover the roof.

A barn is located southeast of the house.


