DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame farmhouse is situated in a hilly wooded area on Fairview Road approximately three miles southeast of New Germany Road. The house faces west. It is a two story, three-bay by two-bay structure with a gable roof.

A wooden porch supported by turned posts runs the length of the facade. The house is entered from the central facade entrance.

Interior brick chimneys are located at each gable end. 2/2 sash windows, framed with plain flat boards, light the house. Two single-pane windows are located at each gable end.

The original, unpainted German siding, framed with cornerboards, is still exposed. Diamond-shaped asphalt shingles cover the roof.

Grained doors are located in the interior of the house. One side is feathered with "burlled walnut", the other side is squiggled in golden oak or maple.
