The Baltimore & Ohio Railroad Station at Loch Lynn has received numerous changes since last surveyed in 1970. Most noticeable is the facade porch which has a frame handicap ramp appended. To the west elevation is a single, block warehouse. At the southwest or track side corner of the main block, the roof overhang has been reworked and a closer, at-grade crossing, porch has been added. When initially surveyed, the exterior siding was erroneously described as "horizontal clapboards." The walls are actually covered with beaded German siding. The tulip-shaped brick chimney has been replaced with a short brick chimney stack.

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The Baltimore and Ohio Railroad Station in Lock Lynn has a plan very similar to that of the Station in Oakland (G-13), i.e. it is a long low building spread out along side the railroad tracks, primarily one storey except for the middle third, which has two peaked gable roofs rising at right angles from it (one is almost twice as large as the other). On the tracks side, a small tower-like accretion rises from between these two roofs (similar to that at the Oakland Station); behind the tower there is a tall tulip-shaped brick chimney. The main roof overhangs from the main building, forming a shelter, and is supported by simple wood trusses. The upper level walls have fish-scale shingling, while the ground level has horizontal clapboards. The gable ends of the smaller cross axis roof has a 'flowering tree' half-timber motif (note similarity with decoration of cottages at Deer Park Hotel, e.g. G-29).

Station is painted pale yellow; roofing is recent asbestos.

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

Built most probably to serve the resort hotels at Mountain Lake Park (1882) and at Loch Lynn Heights, this station is again the likely work of the firm of Baldwin and Pennington, done for the Baltimore and Ohio Railroad, the real developers of Garrett County. Undoubtedly built at about the same time, the Loch Lynn station is a less elaborate version of the one one at Oakland. It has the same massing of forms, the love of changing textures (even in the same material -- wood -- as here), and the use of Queen Anne detailing, [with imaginative paint scheme, these could be enhanced]. The Loch Lynn station is well worth preserving as both an architectural monument in its own right and as a survivor of the great age of the resort hotels.



DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

The B+O Station in Loch Lynn has a plan very similar to that of the station in Oakland - i.e. a long low bldg. spread out along side the track, primarily one storey except for the middle $\frac{1}{3}$ which has 2 peaked gable roofs rising ~~from~~ ^{perpendicularly} from main room, one almost twice as large as the other. Attached the larger of the two there is a small tower-like accretion (like Oakland Station) + a brick  shaped chimney rises ~~between~~ from between 2 cross axis roofs. The main roof overhangs the bldg. ^{from shelter} is supported by simple trusses. The upper level walls are fish scale shingling which ground level has ~~or~~ being clapboards. The ^{smaller} exposed gable ends have half-timber motif (note similarity w/ decoration at Deer Park Hotel Cottages G. 29, 25)

Has new asphalt shingle roof; rest all pale yellow.




