


Since the prior survey, the most notable change to 20 "D" Street is that the two-over-two light, double hung wood sash windows have been replaced with single light, vinyl units. Other alterations include an exterior concrete block flue on the south elevation and a wooden balustrade on the attached front porch. The single leaf front door is a modern unit and appended to the rear is a pressure-treated wood deck.

20 'D' Street, Mountain Lake Park, is a small 2 storey frame dwelling. Covered with clapboards, #20 is a rectangular gable roof structure with the gable end facing the street. The house is without decoration except for the large barge-board-truss affair which fills almost half of the 'pediment' area formed by the gable roof.
