



219 'G' Street, Mountain Lake Park is mentioned here because of its similarity with 22 East Liberty Street in Oakland and shows the Woodward-type board and batten cottage in another Garrett County resort town. Situated across the street from the Round Building [G-26], 219 'G' was undoubtedly associated with the Mountain Lake Park Hotel.
