




The Cottage at the corner of Oak and "G" Street in Mountain Lake Park has undergone a major building addition since last surveyed in 1970. The out of scale and character addition is appended to the southeast corner of the main dwelling. This is a two story, frame, double gabled roofed extension with board and batten siding, six-over-one double hung paired sash units and an exterior single shouldered rick chimney stack. The trellis has been removed from the three sided single story porch.

Not mentioned when originally surveyed is the story and a half, frame gable roofed carriage house. It has elements such as board and batten siding, a shed dormer and six-over-six light, double hung sash windows. Attached to the carriage house's north elevation is an enclosed single story frame carport with an asphalt shingle covered gable roof and board and batten siding.

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This house at the corner of Oak and 'G' Streets in Mountain Lake Park is a board and batten cottage in the manner of Downing and Woodward and is somewhat similar to other cottages of the period, such as 4 and 22 East Liberty Street in Oakland [G-17, G-18] and 219 'G' Street in Mountain Lake Park [G-50]. A bit larger than the similar examples, this house has a large peaked gable in the front of the house, this is filled with a pyramidal arrangement of two windows and a louvred opening. Flanking this main peaked gable are windows whose dormers begin at second storey level and break through the roof. A porch, supported by simple columns, runs around three sides of the first floor.
