The Wayne Evans house is located about 1/2 mile north of the village of Hutton, just where Hutton Road bends sharply to the east towards Oakland. The house is a 2 1/2 story frame American Foursquare style house facing east. A stove chimney rises from the center of the pyramidal hip roof.

The east facade is three bays wide on the first floor. The south and center bays contain large 1/1 sash windows, and the north bay contains a door. A gabled porch with exposed rafter feet covers this bay, and extends north another bay, to cover the end of the porch on the north side of the house. The east porch appears to be in the process of being enclosed. The second floor of the east facade contains two bays, with one 1/1 sash window in each. The east face of the hip roof contains one hip-roofed dormer, with two 1/1 sash windows.

The south facade is three bays wide. The first floor has a slightly-right-of-center door flanked by two large, wide windows, with one small pane over one large one. The second floor contains three 1/1 sash windows, with the center being slightly right of center, like the door below. The south face of the hip roof also contains a hip-roofed dormer with two 1/1 sash windows.

There is also a hip-roofed dormer on the west face of the roof.

The north facade of the house is three bays wide. The first floor is covered by a partially-enclosed porch. The second floor has three 1/1 sash

— windows, with the center window being slightly to the right of center. There is no
dormer on the north face of the roof.
