Located on the west side of Hutton Oakland Road (MD 39) in the village of Hutton, the Tioga Tanning Company Superintendents House is a large, gable-front frame house with some Colonial Revival elements. Facing east, the 2-story house is three bays wide and four bays long, with a 1-story garage addition to the rear.

The east facade has three bays on the first floor, consisting of a door in the south bay and two 2/2 sash windows in the center and north bays, all covered by a porch with Tuscan Columns and a dentiled cornice. This porch extends to the north to form a carport, supported by narrow poles at the north end, which is floored with brick. The second floor of the front facade contains one 2/2 sash window on the south side, and a pair of 2/2 sash windows on the north side. The gable contains one small 1/1 sash window.

The north facade, west of the carport, contains on the first floor, one 2/2 sash window, a bay containing no openings, a pair of 2/2 sash windows, and then one 2/2 sash window. The second floor seems to contain a similar arrangement. The north facade of the 1-story rear wing appears to contain a garage entrance.

The first floor of the south facade contains, beginning on the west end, an exterior brick stove chimney stack, rising above the roof to a corbeled chimney cap, a bay containing no openings, a door, and a shed-roofed one-story addition,

like a bay window without angled sides. This addition contains narrow 1/1 sash windows in the ends, and a pair of these windows on the south side. The second floor of the south facade contains a 2/2 sash window above this addition, which is by necessity quite high, and a 2/2 sash window in the bay just to the west, which is lower. An interior brick stove chimney stack rises from this corner of the building, also with a corbeled cap. The south facade of the 1-story addition contains a 1/1 sash window in the west bay and a door with three lights and three panels in the east bay.

The west facade of the house is covered on the first floor by the gabled 1-story garage addition, which has no openings on its west facade. The second floor of the house contains two 2/2 sash windows.
