The Mildred W. Dunbar Barn, probably built in the early twentieth century, attests to the primacy of agriculture in the Oakland region in the early and mid-twentieth century. Agriculture had been the predominant economic activity outside of Oakland in the late nineteenth century, as farmland comprised about 50 percent of the county's land mass in 1880, and more than 60 percent by 1910. Farms of this period typically raised potatoes, orchard products, oats, corn, buckwheat, wheat, rye, and barley as well as cattle, sheep, swine, and horses. Even in the subsequent decades of the twentieth century, as mechanization began to alter many farming practices, most of the area's residents were still employed in agriculture. Twentieth-century farms in the area focused on producing milk, potatoes, hay, corn, small grains, buckwheat, oats, garden vegetables, and maple sugar. The Dunbar barn, although now semi-ruinous and apparently used only for storage, still stands on a large open parcel of pasture or cropland.

Research has not identified any associations with the lives of persons significant to the Oakland area's past or with events that have contributed significantly to broad patterns of the area's historical development. The architecture does not represent a particularly distinctive type, period, or method of construction, nor does it represent the work of a master, possess high artistic values, or represent a significant and distinguishable entity whose components may lack individual distinction. This resource has not yet yielded and is not likely to yield significant information important in history or prehistory.

This is a one-story, gable-roofed frame barn with a prominent advertisement that says "CHEW MAIL POUCH TOBACCO" painted on one gable. The doors of the barn face east. It stands on a mostly open and gently sloping piece of land about two miles south of Oakland.

The foundation was not visible when the building was surveyed due to a significant snow cover. The barn is clad in vertical wooden boards and topped with a standing seam metal gable roof. When the barn was surveyed, its roof was partially ruinous. The overall color of the building is a weathered brown, although its southwestern gable is painted red.

Two fixed six-light sash windows are evenly placed within a large inset area in the southwestern gable. A second-floor door opening on this same gable contains a solid wood door. A third fixed six-light sash window lights the southeast elevation; in addition, two other wooden doors open into this side of the building.

A rectangular concrete foundation of a demolished building stands to the northwest, parallel to the ridge of the barn. The barn stands at the southernmost corner of a rectangular fenced field. A line of trees and underbrush runs behind the building to the southeast. The ridge of the barn parallels MD 219. The walls of the barn are intact, but because the roof is in semi-ruinous condition and now stands open to the weather, this building is threatened by imminent deterioration.




