
The Gilbert and Mary V. Kight House, built *circa* 1940, documents the continued twentieth-century development and settlement of the Oakland area as the result of nineteenth-century resort and hotel development. The Kight House stands near the site of the former Monte Vista Hotel, a prominent area resort hotel which was built around 1880 and demolished a century later. Although the prominence of the region as a resort area had diminished somewhat by the third and fourth decades of the twentieth century, the Oakland area still remained an important local mercantile and community center and continued its growth throughout this period.

Research has not identified any associations with the lives of persons significant to the Oakland area's past or with events that have contributed significantly to broad patterns of the area's historical development. The architecture does not represent a particularly distinctive type, period, or method of construction, nor does it represent the work of a master, possess high artistic values, or represent a significant and distinguishable entity whose components may lack individual distinction. This resource has not yet yielded and is not likely to yield significant information important in history or prehistory.



This is a one-story, two-by-two-bay, pyramidal-roofed mid-twentieth-century frame dwelling with a gable-roofed rear addition, a single exterior brick chimney, and a cutaway front porch that has been extended by an open-sided gable-roofed front porch. The house is built on a rusticated concrete block foundation, is clad in yellow wavy-edged asbestos siding, and is topped with a pyramidal roof. Windows are primarily a mixture of single and paired three-over-one double-hung sash. The front entrance contains a paneled wooden one-light half-glass door. A gable-fronted concrete block garage stands nearby. The house faces east and occupies a flat, wooded site about two miles south of Oakland.

This is a one story, two-by-two-bay, pyramidal-roofed mid-twentieth-century frame dwelling with a gable-roofed rear addition and a cutaway front porch that has been extended by an open-sided gable-roofed front porch. The house faces east and occupies a flat, wooded site about two miles south of Oakland.

The house is built on a rusticated concrete block foundation that encloses a full cellar. The walls are clad in yellow wavy-edged asbestos siding finished with plain flat wooden corner boards. The building is topped with a pyramidal roof finished with a wooden eave and verge. The roofing material could not be observed when the house was surveyed due to a significant snow cover. A single exterior brick chimney rises on the southwest elevation. A rectangular louver near the peak of the rear gable ventilates the attic.

Windows are a mixture of single and paired three-over-one double-hung sash finished with flat wooden surrounds. Several fixed six light sash windows are also present, and a number of fixed three-light sash windows light the cellar. The front entrance, which is located in the cutaway section of the northeast elevation, contains a paneled wooden one-light half-glass door. The rear door leads into the northeast elevation of the rear addition, but was not visible when the house was surveyed. A cellar entrance on the southwest elevation contains a paneled wooden door. All door openings are finished with plain, flat wooden surrounds.

The front porch rests on a plain concrete block foundation. It includes a wooden deck, wood railing, lattice balustrade, a wooden ceiling, and four-by-four wooden posts. A short flight of wooden ladder steps leads from the yard up to the level of the porch deck. The porch gable is clad in asbestos siding to match the rest of the house. Although no rear porch is present, a short flight of open concrete steps leads up to the rear addition.

A gable-fronted concrete block garage stands just north of the house. Built with a concrete block foundation and walls, the garage is topped with a gable roof that was snow-covered when the building was surveyed. The upper portion of one gable is clad in composition siding, while the top of the other gable is sheathed in vertical boards. Two pairs of double wooden doors in the southeast gable and two standard-sized wooden doors in the opposite elevation provide access to the interior. Five windows pierce the northeast elevation; two additional windows pierce the opposite wall.

The house stands on a partially wooded, flat site just west of a sharp curve in Monte Vista Road. A driveway extends from this curve in the road northwestward toward the garage. Several evergreens and a few deciduous trees shade the area closest to the house. A narrow forked creek spanned by a small footbridge runs along the property's southwestern border, and a one-story concrete block shed stands beyond the creek to the west. The house may have been vacant when property was surveyed, but still appears to be in fair condition.






**Resource Sketch Map**
