The Robert E. and Alice M. Proudfoot House, built *circa* 1925, documents the early and mid-twentieth-century development and settlement of the Oakland area as the result of nineteenth-century resort and hotel development. Although the prominence of the region as a resort area had diminished somewhat by the third and fourth decades of the twentieth century, the Oakland area still remained an important local mercantile and community center and continued its growth throughout this period. The Proudfoot House stands near the site of the former Monte Vista Hotel, a prominent area resort hotel which was built around 1880 and demolished a century later. The Proudfoot House was originally built as a cottage to house the caretaker for the hotel, but this property was split off from the Monte Vista property in the mid-twentieth century.

This property is associated with events that have contributed significantly to broad patterns of the area's historical development. Research has not identified any associations with the lives of persons significant to the Oakland area's past, however. Also, the architecture does not represent a particularly distinctive type, period, or method of construction, nor does it represent the work of a master, possess high artistic values, or represent a significant and distinguishable entity whose components may lack individual distinction. This resource has not yet yielded and is not likely to yield significant information important in history or prehistory.

This is a *circa* 1925 one-and-one-half-story three-by-two-bay gable-roofed frame dwelling with pronounced kicked front and back eaves, two permastone-clad chimneys, two full shed-roofed dormers, an open-sided front porch, and a large gable-roofed addition on the northwest gable. The house rests on a permastone-sheathed foundation. It is clad in wooden shingles and stucco, topped with an asphalt-shingled gable roof, and lit mostly by paired and single, one-over-one, double-hung aluminum sash finished with aluminum surrounds. The front and rear entrances contain wooden half-glass doors. A two-story gable-roofed, gable-fronted frame garage/carriage house stands nearby. The building faces southwest and occupies 2 partially wooded and sloping site about a mile south-southwest of Oakland.

The Robert E. and Alice M. Proudfoot House, built *circa* 1925, documents the early and mid-twentieth-century development and settlement of the Oakland area as the result of nineteenth-century resort and hotel development. The Proudfoot House stands near the site of the former Monte Vista Hotel, a prominent area resort hotel which was built around 1880 and demolished a century later, and was originally built as a cottage to house the caretaker for this hotel.

This is a *circa* 1925 one-and-one-half-story three-by-two-bay gable-roofed frame dwelling with pronounced kicked front and back eaves, two full shed-roofed dormers, an open-sided front porch, and a large gable-roofed addition on the northwest gable. The building faces southwest and occupies a partially wooded and sloping site about a mile south-southwest of Oakland.

The house rests on a permastone-clad foundation that encloses a full cellar. The walls are sheathed in green wooden shingles with white trim, and the building is topped with an asphalt-shingled gable roof finished with a wooden eave and triangular eave brackets. Stucco coats the lower portion of the south elevation. An interior masonry chimney rises from the southwest slope of the roof, and a second exterior stack rises on the northwest elevation. Both chimneys are clad in permastone.

Windows are mostly paired and single, one-over-one, double-hung aluminum sash finished with aluminum surrounds. One large three-light casement window on the northeast elevation lights the main floor, and two large six-light fixed sash focal windows on the same elevation light the main floor and the basement levels of the gable-roofed addition. The rear entrance, located on the northeast elevation of the main block, contains a wooden half-glass door. A second entrance nearby leads into the southeast elevation of the gable-roofed addition. The front entrance, which pierces the southwest elevation of the main block, contains a multipaned half-glass wooden door.

The open-sided two-level rear porch is formed by an extension of the roof over the main block. It consists of square wooden pillars that support a balustraded deck at first-floor level; this porch deck shelters a concrete patio directly below. The front porch, which also stands under an extension of the roof over the main block, has been fully enclosed with one-over-one double-hung aluminum windows.

A two-story gable-roofed, gable-fronted frame garage/carriage house with two one-story shed-roofed extensions stands to the southwest. This building houses two cars. It is built on a permastone-clad concrete foundation, sheathed in a mixture of wooden drop siding and permastone with flat wooden corner boards, and topped with an asphalt-shingled gable roof finished with exposed rafter feet. Two wood and glass garage doors pierce the northwest elevation, and several double-hung wooden sash windows light the interior. An open trellised patio with a stone fireplace stands east of the house. A small one-story frame shed and an open grape arbor are also located nearby. A curving driveway leads from Monte Vista Road along the west side of the house, terminating in front of the garage/carriage house. An L-shaped sidewalk links the garage and the front entrance. The road to a former hotel that once stood nearby extends southeastward from the garage /carriage house. The house is presently occupied and in good condition.





