The Friend House, located on the west side of MD 39 at 5581 Hutton Road, is a single story, front gable-roofed frame house with a rectangular floor plan. The house is built into the upward slope of a hill.

Constructed in the latter half of the 1930s, the Friend House is indicative of a pattern of settlement expansion into areas then outlying Oakland's town limits. The house is typical of Recovery Era domestic architecture.

The Friend House is located on the west side of MD 39 at 5581 Hutton Road. Built into the upward slope of a hill, the rear or west side of the property drops off rapidly and is bordered by the base of a mountain. The north and south elevations are bounded by adjacent houses while the east is bounded by the road's pavement edge. Sited perpendicular to the highway, a gravel driveway on the south side provides egress to the property.

Built in the late 1930s, the single story, frame, front gable-roofed house is rectangle-shaped. Other features include a three-bay-wide facade, an exterior concrete block chimney, and a rusticated formed concrete block foundation. The full length rear porch is partially enclosed and sits upon the extended foundation wall. A half flight of wood stairs accesses the wooden floorboards while a door in the foundation leads directly to the lower level of the house. The entire dwelling is covered with vinyl siding. The three-bay-wide front porch has a concrete base, four fluted aluminum columns and the northernmost bays are sheltered by a gable roof which extends from the main block. The facade is punctuated by a three sided bay window. Just west of the chimney on the roof, is a small nonfunctional gable.

Except for one vertical, sliding, single-light unit on the south wall, the rest of the windows are single light, double hung sashes with wood trim. The asymmetrical front door is a single leaf unit with an upper glass panel and a lower wood panel. A modern, single story, aluminum clad and flat roofed outbuilding is located at the rear of the property.

The Friend House, according to an elderly resident was built in the late 1930's, is indicative of a pattern of settlement expansion in outlying areas beyond Oakland's town limits. Newly constructed or realigned roads opened unusable agricultural lands to residential development. Sometimes in the mid 1930's the old road to Crellin MD 39 relocated to its existing location. Soon thereafter, lots were subdivided into one and two acre parcels along Hutton Road. This house is typical of Recovery Era domestic architecture.





Oakland Vicinity, Garrett County




Location Map
