

The Welling House is located on the east side of MD 39 at 5362 Hutton Road. The original single story, wood frame, side-gable roofed main block has a three-bay-wide facade and an interior brick chimney stack. In the 1980s the south and east elevations were extended to incorporate additional living space.

The Welling House, built in 1940 according to county tax records, is associated with a settlement expansion pattern in fringe areas outside the town limits of Oakland. Although altered by modern additions, the main block is typical of mid-twentieth century domestic architecture.

The Welling House is located on the east side of MD 239 at 5362 Hutton Road. The rear or east side of the property is bounded by a sharp descending hill, a board fence on the south elevation, the road's edge of pavement to the west, and a gravel driveway to the north. The dwelling sits back from and parallel to the road.

The original single story, wood frame, side-gable roofed main block has a three-bay-wide facade and an interior brick chimney stack. In the 1980's the south and east elevations were extended to incorporate additional living space. The entire house is covered with painted wood shingle siding and the roof is sheathed with asphalt shingles. A rusticated pattern concrete block foundation wall supports the c. 1940 main block while modern concrete block is found under the modern wing.

There are two window types: 3/1 light double hung sashes which are original; and modern, single-light, double hung units. The projecting gable-roofed facade entrance has a nine light and wood mullion door which is approached by four concrete steps. At the rear, a wood frame deck encircles an above ground swimming pool. Located behind the pool are two modern outbuildings. The larger of the two is a two story concrete block, gambrel roofed shop building and the other building is a single story, frame, shed-roofed shed.

The Welling House, built in 1940 according to county tax records, is associated with a settlement expansion pattern in fringe areas outside the town limits of Oakland. Increasing popularity of the automobile in the 1920's and 1930's prompted the construction of new and improved road networks through, in some cases, previously used agricultural lands. In the mid 1930's, Hutton Road was realigned to its existing location and it in turn, helped spur residential development. Although altered by modern additions, the main block is typical of mid-twentieth century domestic architecture.




