
The Owen B. and Suzanna Frazee Barn attests to the primacy of agriculture in the Oakland region in the early and mid-twentieth century. Agriculture had been the predominant economic activity outside of Oakland in the late nineteenth century, as farmland comprised about 50 percent of the county's land mass in 1880, and more than 60 percent by 1910. Farms of this period typically raised potatoes, orchard products, oats, corn, buckwheat, wheat, rye, and barley as well as cattle, sheep, swine, and horses. Even in the subsequent decades of the twentieth century, as mechanization began to alter many farming practices, most of the area's residents were still employed in agriculture. Twentieth-century farms in the area focused on producing potatoes, hay, corn, small grains, buckwheat, oats, garden vegetables, and maple sugar, and dairying became a significant regional agricultural pursuit. According to the current property owner, the Frazee barn is presently used only for storage, but once served as the granary for a large dairying operation that included three now-demolished dairy barns. The Frazee barn still stands on a large open parcel of pasture or cropland.

Research has not identified any associations with the lives of persons significant to the Oakland area's past or with events that have contributed significantly to broad patterns of the area's historical development. The architecture does not represent a particularly distinctive type, period, or method of construction, nor does it represent the work of a master, possess high artistic values, or represent a significant and distinguishable entity whose components may lack individual distinction. This resource has not yet yielded and is not likely to yield significant information important in history or prehistory.



This is a one-story, gable-fronted, bow-roofed barn with pronounced kicked eaves on either side. Built on a stone foundation, the barn is clad in wooden drop siding and vertical wooden boards and topped with a corrugated metal bow roof. A two-over-two double-hung wooden sash window with wooden trim lights the front gable, and a single long horizontal tripartite fixed-sash window pierces the rear gable. Both front and rear entrances are embanked and contain double swinging vertical board doors with wooden trim. This building once served as the granary for a large dairying operation but is now used for storage. It faces southeast and is located on an open section of land about one mile northeast of Oakland.

The Owen B. and Suzanna Frazee Barn attests to the primacy of agriculture in the Oakland region in the early and mid-twentieth century. Agriculture had been the predominant economic activity outside of Oakland in the late nineteenth century, as farmland comprised about 50 percent of the county's land mass in 1880, and more than 60 percent by 1910. This is a one-story, gable-fronted, bow-roofed barn with pronounced kicked eaves on either side. Each of these eaves covers a narrow, full-length, one-story extension. The barn faces southeast and is located on an open section of land about one mile northeast of Oakland.

Built on an undressed and roughly coursed stone foundation, the barn is clad in a combination of brown wooden drop siding and vertical wooden boards finished with flat wooden corner boards. It is topped with a rusty brown corrugated metal bow roof finished with wooden eaves and exposed rafter feet. A small shed-roofed metal roof extension shelters a standard-sized entrance projecting from the rear of the southwest elevation.

A single two-over-two double-hung wooden sash window finished with wooden surrounds lights the front or northwest gable. The rear or southeast gable is lit with a single long horizontal tripartite fixed-sash window placed near the top of the gable. The front entrance is centered on the northwest gable and contains double outward-swinging vertical board doors finished with flat wooden surrounds. The rear entrance, located on the opposite gable, is fitted with a similar set of double doors. A standard-sized entrance on the southwestern elevation contains a paneled wooden door with flat wooden surrounds.

A stone embankment leads up to the front entrance. A similarly-sized wood plank and gravel ramp leads to the double doors on the rear gable. A large partially-embanked pond is located south of the barn. Although no additional buildings stand on the property, two former dairy barns once stood just to the northeast of the barn, and a third dairy barn once stood immediately to the southwest. The building that remains was once used as the granary for this large dairying operation, but is now used for storage; it remains in good condition.






Resource Sketch Map


