The Robert E. Glotfelty House, built *circa* 1940, relates to the continued expansion and settlement of the Oakland and Mountain Lake Park areas in the mid-twentieth century. The development of summer vacation resorts and hotels in the Oakland area in the late nineteenth century had helped to stimulate settlement of the region. Although no longer as prominent a resort in the mid-twentieth century, Oakland still remained an important local mercantile and community center, and continued its growth throughout this period. Residential development typically occurred along pre-existing road networks. The Glotfelty house exemplifies much of the region's mid-twentieth-century residential architecture.

Research has not identified any associations with the lives of persons significant to the Oakland area's past or with events that have contributed significantly to broad patterns of the area's historical development. The architecture does not represent a particularly distinctive type, period, or method of construction, nor does it represent the work of a master, possess high artistic values, or represent a significant and distinguishable entity whose components may lack individual distinction. This resource has not yet yielded and is not likely to yield significant information important in history or prehistory.

This is a one story, two-by-three bay, gable-roofed, gable-fronted frame swelling with multiple shed-roofed additions. The house is constructed with a mixed rusticated and plain concrete block foundation, aluminum-sided walls, an asphalt-shingled gable roof with two exterior masonry chimneys, and mostly single one-over-one, double hung sash windows with aluminum trim. Door openings contained either modern sliding glass doors or paneled wood and glass doors. A gable-roofed, gable-fronted garage stands on the lot. The house faces south-southwest and occupies an open, sloping lot on Memorial Drive about one-and-one half miles east-northeast of Oakland.

This is a one-story, two-by-three-bay, gable-roofed, gable-fronted frame dwelling with multiple shed-roofed additions. The house faces south-southwest and stands on an open, sloping lot on Memorial Drive about one-and-one-half miles east-northeast of Oakland.

The main block of the house is built on a rusticated concrete block foundation that encloses a full cellar; the foundations that support the front and rear shed-roofed additions consist of plain concrete block. The walls are clad in white aluminum siding with brown trim, and the building is topped with an asphalt-shingled gable roof finished with an aluminum eave. Two exterior chimneys rise on the northwest elevation; one is built of brick with a projecting clay flue tile, and the other is constructed of concrete block.

Windows consist primarily of single one-over-one, double-hung sash finished with aluminum surrounds. Several horizontal sliding one-over-one aluminum windows pierces the southwest elevation of one of the shed-roofed additions, and a tripartite focal window lights the westernmost corner of the main block. The front entrance, which is located on the southeast elevation beneath a shed-roofed entry, consists of a modern sliding glass door finished with aluminum surrounds. The rear entrance, which pierces the same elevation of the rear shed-roofed addition, contains a paneled wooden door lit by a three-light glass sash above; this opening is also finished with aluminum surrounds.

Two small shed-roofed entry porches shelter these entrances: each porch is built on a concrete block foundation, clad in plywood siding, and topped with a corrugated metal roof, and each porch also features an astroturf-covered concrete deck and astroturf-covered concrete steps.

A gable-roofed, gable-fronted, one-story, two-car garage stands northeast of the house. This building consists of a gable-roofed main block with a shed-roofed addition which houses a second garage bay; another small shed-roofed addition is attached to the northeast elevation. Built on a concrete block foundation, this garage is sheathed in plywood and topped with a rolled asphalt roof finished with an aluminum eave. Two overhead fiberglass garage doors provide access to the building, and several two-over-two fixed sash windows light the interior.

The house stands on a roughly rectangular lot facing Memorial Drive. A long gravel driveway oriented perpendicular to the road runs along the southeast elevation of the house and leads northeastward toward the garage. A concrete walk leads from the driveway to the rear entrance of the house. A wooden picket fence runs along the northwest side of the lot. The property is mostly open, but the house is shaded by several deciduous and coniferous trees. A cultivated farm field stands to the southeast. The house is presently occupied and in good condition.



