DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Potomac State Forest is located in southeastern Garrett County. It contains 12,400 acres of land in scattered tracts on Backbone Mountain along the Potomac River. The area consist of rugged forest land underlain with deposits of coal.

Prior to its becoming a state forest this land was prime logging territory and also helped to support several nearby coal mining communities such as Kempton, Shallmar and Vindex. Today there are extensive strip mining operations on property adjacent to the state forest land. The State began to acquire this forest in 1931. In the mid-1930s it was the location of the Civilian Conservation Corps activity.

The only structures included in the state forest property of which the staff is aware, is the superintendent's residence built by the CCC. The pavilion was rebuilt in 1976. Other structures are modern and include service buildings and garages. A wooden walkway was built in 1977 with CETA labor.

The CCC vintage house is a one-and-a-half story, five-bay building resting on low coursed stone foundations. It is constructed of stacked logs without the use of chinking or daubing. The logs are cut flat on the top, bottom and inside surfaces. The exterior surfaces are stripped of their bark and formed in a peaked curve. At the corners alternate courses of logs overlap, extending beyond the surface of the building. A projecting bay forms a wall dormer with a gabled roof. The chimney is of coursed stone construction with corbeling at its top. Part of the front elevation is recessed beneath a shed roofed porch. The porch has a balustrade of upright logs.

The structures appear to be in excellent condition.

STATEMENT OF SIGNIFICANCE

The structures on the Potomac State Forest land reflect the pervasive form of CCC construction. This is an important form of log building developed during the CCC period. The CCC construction does not represent a traditional form of log building.

The Potomac State Forest is also associated with the 19th century lumber industry which was a mainstay of the economy of Garrett County. The importance of the coal industry also affected the Potomac State Forest.

According to literature distributed by DNR, during the late 19th century, reckless logging methods and frequent forest fires had threatened the lumber industry and the local economy. The State began its acquisition program in 1931 to protect the natural resources and to stabilize the economy.

RECOMMENDATIONS

Potomac State Forest and adjoining Garrett State Forest cover a vast number of acres of rugged mountain land in Garrett County. Historical data that has been gathered about this state forest reveals that it was significant in the logging and coal industries during the late-19th and early-20th centuries.

It is recommended that these activities be incorporated into historical information published by DNR. Potomac State Forest has already included historical background in its literature, describing how DNR acquired the land and how the state forest was established. An effort might be made to develop explanations and interpretations of the logging, mining and Civilian Conservation Corps activities and remaining structures and sites for hikers and campers.


