The Jehue Paugh House is located south off Upperman Road, in a hollow. The house is surrounded by trees

The house is a two-story, gable-roof, ell-plan dwelling. The original facade on the south elevation has been obscured by blocking the original door. The ell on the north and west elevations is filled with a one-story, shed-roofed enclosed porch.

The house rests on a stone foundation and is covered by tar paper. The windows are sash of varying lights and have plain board surrounds. The roof is covered with tar paper.

The house has two interior brick stove chimneys, one on the main block and one on the ell. On the west gable end is an exterior cinderblock stove chimney. The interior arrangement of the house is unknown.

This house is an example of a common western Maryland type. Houses of this general configuration, a rectangular main block and rear kitchen wing, were constructed in Garrett County from the late nineteenth through the early twentieth centuries.


