DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The G. W. Kimmell House is located on the east side of Boiling Spring Road, about half a mile southeast of Deer Park.

The house is a two-story, gable-roofed dwelling with a three-bay, center-door facade. The facade points southwest and is covered by a one-story, shed-roofed porch. A shed-roofed, two-story addition is attached to the northeast elevation of the house, and a one-story, shed-roofed storm porch built of modern cinderblock is attached to the addition's northeast elevation.

The house rests on a stone foundation and is covered by weatherboarding and German siding. The windows are two over two sash and have plain board surrounds. The roof is covered with asphalt shingles.

The house has two stove chimneys, an exterior cinderblock chimney on the southeast elevation and an interior brick chimney also on the southeast elevation. The facade porch roof is supported by square posts.


