DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame farmhouse is situated in a hilly semi-wooded area on Pine Hill Road approximately 1/4 mile north of MD Rt. 135 and Swanton. The house faces southwest. It is a two story, three bay by two bay structure with a gable roof. A porch, supported by slightly tapered wooden posts extends the length of the facade, as well as the northwest and southeast elevations. A single story, one bay by two bay gable roof structure is located off the far rear end of the porch at the northwest elevation.

An exterior brick gable end chimney is located on the southeast elevation. Two over two sash windows light the house. The house rests on a poured concrete foundation. The original German siding exterior has been covered with asphalt shingles as is the roof.

A garage and privy both German sided are located to the northwest of the house, a shed to the southeast.
