The Darrell H. Rohrbaugh House is a rectangular, two-story, gable-roofed building of vertical plank construction. It rests on a stone foundation with a full basement and is sheathed with weatherboard siding. The facade consists of three irregularly spaced bays with two, four-panel doors at the center and full length, partially enclosed porch. The interior is divided into a two room plan by an enclosed, center staircase.

A frame bank barn on a poured concrete foundation is associated with the house.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Darrell H. Rohrbaugh House is located between U.S. Route 50 and Ben Dewitt Road approximately 1.3 miles west of U.S. Route 219. Access to the house is from a dirt lane off U.S. Route 50. The facade points north.

The house is a rectangular, two story, gable-roofed building of vertical plank construction. Its facade consists of three irregularly spaced bays with two, four-panel doors at the center, and a full length, partially enclosed porch.

The house rests on a coursed, roughly squared stone foundation with remaining traces of whitewash. The walls consist of three layers of board: a vertical plank structural layer, diagonal board on the interior, and weatherboard with cornerboards on the exterior. Its windows are two over two sash with plain board surrounds and drip moldings. The roof is covered with asphalt, has exposed rafter ends, and one interior brick chimney on the ridgeline.

A shed porch runs the full length of the facade and terminates in a small enclosed room, known as "the pantry," at the northwest end. This room has outside access only. The porch rests on stone footings, has three square posts with chamfered corners, and a rail running through the posts.

The interior is a two room, center stair plan. This stairway is an eleven tread, closed, straight run, enclosed at the bottom by a four panel door. Machine sawn ceiling joists are left exposed, and the walls are papered directly over the diagonal board. A square opening in the ceiling of the second floor northwest corner leads to the attic.

The house has a full basement of stone with a whitewashed interior and a bulkhead entrance on the east endwall.

Northeast of the house is a frame bank barn on a poured concrete foundation.




Table Rock, MD-WV
