DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Lathe Holland House is a two story, gable-roofed, frame building on a stone foundation. Its basic configuration is a five bay by two bay, center hall plan with a two story rear ell, and both facade and rear porches. All elevations are sheathed with weatherboard siding.

The facade (SE elevation) has a symmetrical five bay, center door arrangement and a full length hip-roofed porch. Windows on this elevation and all other elevations are 2/2 sash with plain board surrounds. A single-light transom tops the door. The porch has had its turned posts replaced with four Tuscan columns set on brick piers.

The southwest and northeast endwalls are both lit by a symmetrical arrangement of four windows, two per floor. The rear wing is attached to the northwest elevation at its western end. A shed-roofed porch with turned posts and spindle brackets extends across the northeast side of the wing and continues across the rear wall of the main block.

Originally sheathed with wood shingles, the roof has been recovered with asphalt shingles. Three interior brick stove chimnies are situated along the ridgeline: one at each endwall of the main block and one at the center of the rear wing. Its box cornice forms partial gable end returns and is underlined by a plain board frieze.

The interior of the house is a two room, center hall plan. A twelve tread, straight run staircase rises along the northeast wall of the hall to a landing, then rises an additional five treads in the opposite direction. The newel post and balusters, spaced two per tread, were hand turned.

STATEMENT OF SIGNIFICANCE

The frame of the house is constructed of white pine and yellow poplar that was sawn on an up and down mill located at the headwaters of Cherry Creek. The studs are placed on sixteen inch centers, alternating 2" x 4" and 4" x 4" pieces of lumber.

The interior is a two room, center hall plan. A twelve tread, straight run staircase rises along the northeast wall of the hall to a landing, then rises an additional five treads in the opposite direction. The newel post and balusters, spaced two per tread, were hand turned.




Table Rock, MD-WV
