The Ray C. Arnold House is a frame two-story, gable-roofed, ell-plan building on a cement block foundation. Its facade has a symmetrical three bay, center door arrangement with a recently added one bay entrance porch. All windows are 2/2 sash with plain board surrounds. Weatherboard siding sheathes the exterior walls.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Ray C. Arnold House is located on the south side of Ben Dewitt Road approximately .7 mile southwest of U.S. Route 219. The house and a barn are situated on opposite sides of a small pond .3 mile from the road.

The house is a frame, two story, gable-roofed building with its facade oriented to the southeast. Its basic configuration is a three bay by one bay block with a two story, one bay by one bay rear ell. A recent shed porch fills in the northeast side of the ell.

The facade has a symmetrical, three bay, center door arrangement. A recent, gable-roofed, one bay entrance porch shelters the door. This small porch sits on a roughly squared stone foundation and has two square wood posts at each corner to support the roof. There are two other entrances to the building: one on the northwest side of the house and another on the northeast side of the ell.

All windows are two over two sash with narrow plain board surrounds and simple drip moldings. The exterior walls are covered with weatherboard and cornerboards and the building rests on a cement block foundation. A batten door basement entrance is located on the northeast endwall.

The roof is covered with asphalt shingles and has a box cornice with partial gable end returns and a plain board frieze. An interior brick chimney is located on the ridgeline where the main block joins the rear ell.

The rear porch sits on a foundation of coursed, roughly squared stone with a small grindstone embedded in its northeast side. The shed roof is supported by four square wood posts (two are placed at the north corner).

East of the house is a small pond, and further northeast is a frame bank barn of fairly recent construction.
