DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame house is situated in a hilly wooded area on Lyndale Road, approximately .5 miles northeast of Bernard Road. The house faces northwest. It is a two story, three bay by one bay structure with a gable roof. A single story shed additions run the length of the house on the facade and on the rear, southwest, elevation. The house is entered from the northeast elevation of both additions.

The house is lit predominately with two over two and one over one sash windows. Both additions are covered with a row of consecutive windows. The house rests on a new foundation. The original weatherboard siding is still exposed in the gable ends. Aluminum siding covers the additions and the northeast and southwest elevations of the house. Tarpaper covers the facade, the rear and the roof.
