DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame house is situated in a semi-wooded area off Sunnyside Road, approximately 2.5 miles northwest of Route 219. The house faces east. It is a two story, three bay by one bay gable roof structure. A single story shed addition two bays deep extends across the rear west elevation. A porch, supported by plain chamfered wood posts and partially enclosed at the south end extends across the facade. Aside from the facade entrance two others are located on the north elevation; one on the main block with a gabled overhang, the other on the shed addition.

Two over two sash windows light the house. The house rests on a concrete foundation. "Brick" asphalt shingles cover the house framed with cornerboards. Tar paper covers the roof.




Table Rock, MD:WV
