The L.J. Swartzentruber House is a 2-story brick, four bay by 3 bay structure with a bracketed gable roof. Its unusual plan is marked by diagonally symmetrical opposing 2-story inset porches. It was built in 1908 by Asa Coddington for Lewis J. Swartzentruber and is one of few brick dwellings in southern Garrett County.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This brick farmhouse is situated in Pleasant Valley approximately ½ mile southwest of the town of Gortner. The house faces northwest. It is a two story, four bay by three bay structure with a bracketed gable roof. A 2-story wooden porch supported by chamfered posts with square balusters is inset into the west half of the facade and runs along the northeast elevation.

A similar pattern, with inset porches, probably existed on the rear, southeast elevation but has been filled in with a two story ceramic tile addition. Entrances are located on the facade, at the northeast elevation, at the southwest elevation of the ceramic tile addition and on the second story of the northeast elevation.

The house has two symmetrically located central brick chimneys and an interior brick chimney at the rear elevation. Two by two sash windows, with concrete sills and lintels, light the house.

The cellar is entered from the southeast elevation. The house is constructed of brick and rests on a poured concrete foundation. Asphalt shingles cover the roof.

The interior was not examined.

A frame barn on a stone foundation is also located on the property.

STATEMENT OF SIGNIFICANCE

The Swartzentruber House was built in 1908 by Asa Coddington for Lewis J. Swartzentruber. It is said that the brick for the house was made on the farm at the reported site of Ashby's Fort.

The house is also significant for its unusual exterior configuration marked by diagonally symmetrical opposing two-story inset porches.




Table Rock: MD;WV
