The John G. Hoffman House stands high on the side of a hill facing Gorman and Gormaniana to the northeast. The house is a largely proportioned, two story, balloon frame building on a stone foundation. Its basic configuration is a five bay by three bay square plan with a steeply pitched cross gable roof rehabilitation most of the exterior ornamentation was removed. The interior is a double pile, center hall plan with a fireplace in each room and servants' quarters in the attic. A small frame barn and another smaller outbuilding are also included with the site.

The John G. Hoffman House is one of the grandest houses in the rural areas of Garrett County both in terms of size and details. Although the exterior has been altered and stripped of its ornamentation, the interior does retain its original decoration which includes carved stone fireplace surrounds, interior shutters, ornate staircases leading to both the second floor and the attic level, and servants quarters. It is thought that the fireplace surround were imported from Italy. This house was built for Hoffman as a summer home.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The John G. Hoffman House stands high on the side of a hill facing Gorman and Gormaniana to the northeast. The house is a largely proportioned, two story, balloon frame building on a stone foundation. Its basic configuration is a five bay by three bay square plan with a steeply pitched cross gable roof rehabilitation most of the exterior ornamentation was removed. The interior is a double pile, center hall plan with a fireplace in each room and servants' quarters in the attic. A small frame barn and another smaller outbuilding are also included with the site.

The facade (E elevation) has a symmetrical, five bay, center door arrangement, three bays across on the first floor and five bays across on the second floor. A pair of raised five-panel doors and a large two-light transom fill the doorframe. The windows on this elevation, and the other elevations of the main block, are elongated 1/1 sash, the sash having been recently replaced. A smaller 1/1 sash pierces each gable. According to the owners, a porch with elaborate spindle ornamentation was removed from the facade.

The south elevation is articulated by two, two-story bay windows with shallowly pitched hipped roofs and lattice work around their foundations. The north elevation is pierced by three bays of 1/1 sash windows asymmetrically spaced on the wall.

The rear wing occupies only half of the west elevation on the main block, leaving room for a window and a door on that wall. The shed-roofed porch that shelters this is a recent addition. The wing is a full two stories high, but appears shorter than the main block because of the shallower pitch of its gable roof. The rooms were removed from its west end, and all of its window openings have been rearranged and replaced with modern sash. The interior of the wing houses a modern kitchen and bathrooms.

All of the exterior wall surfaces have been sheathed with aluminum siding. This process caused the removal of the door and window surrounds as well as any other ornamentation that may have been present. The roof is covered with asphalt shingles and has two large brick chimneys situated on the north-wouth ridgeline, one on either side of the crossing ridgeline. Six scroll brackets, embellish the short piece of box cornice that forms the gable end returns at each corner.

The interior is divided into four rooms of equal size per floor. A seventeen tread, straight run staircase rises along the south wall of the hall with turned balusters spaced two per tread. The newel post is square, has reeded surfaced, rope moldings at the corners, and sunburst panels near the top. From the second floor a similar flight rises sixteen treads to the attic. Each of the eight rooms is equipped with a fireplace at the center of its partition wall. Seven of the fireplace surrounds are made of carved stone. The fireplace in the second floor, southwest room has a metal surround that is painted to look like stone. Interior shutters are provided for the bay windows and five-panel doors are found throughout the house.

Two small servants bedrooms are located in the attic, set up as simple partitions at the north and south ends of this otherwise unfinished level.

The barn is a gable-roofed, frame building with board and batten siding on a washed stone foundation. One of the rooms on the first floor is paneled with vertical tongue and groove board, and is thought to have been used as a tack room. Servants quarters occupy the second floor.

STATEMENT OF SIGNIFICANCE

The John G. Hoffman House is one of the grandest houses in the rural areas of Garrett County both in terms of size and details. Although the exterior has been altered and stripped of its ornamentation, the interior does retain its original decoration which includes carved stone fireplace surrounds, interior shutters, ornate staircases leading to both the second floor and the attic level, and servants quarters. It is thought that the fireplace surrounds were imported from Italy.¹

In 1889, Hoffman's enterprise, T.G. Hoffman and Sons, assumed operation of the tannery in Gormanian, one of the largest tanneries in the state. Previous to this, Hoffman's business had been based on Wheeling, West Virginia. This residence was built for Hoffman as a summer home.²


