DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The E. L. Perkins House is located on the west side of the Kempton Road on a dirt lane approximately .9 mile south of Tablerock Road.

The house is a T-plan, story and a half, gambrel-roofed building of log construction. Its facade is located on the southeast side of the extension and is sheltered by a shed porch. Two frame, one story wings are later additions: a shed wing on the northwest side and a hipped roof wing on the northwest side.

The logs used to construct the walls were left in the round and are now covered by a brick patterned sheet metal while the gambrel ends are covered with board and batten siding. All windows in the original block are one over one sash with plain board surrounds.

The gambrel roof has flared eaves and is covered with asphalt shingles. An interior cement block chimney is located on the ridgeline southwest of the roof crossing.
