A January 1997 field review of the house at 120 North Second Street revealed that a few changes to the structure's fabric had occurred since it was first documented in 1975. A vertical plank apron wall skirt and a new wooden plank deck compose the dwelling's porch. Vinyl siding has been applied to most of the house's exterior wall surfaces. Brackets that ornamented the building's cornice have been replaced with an aluminum fascia. To the rear, west, of the house stand two outbuildings not documented by prior survey efforts. These buildings consist of a one-story, hipped-roof frame garage, and a one-story, gable-roofed frame shed.



<p>120 North Second Street in Oakland, Garrett County, stands on the west side of the street in the block formed by Pennington and Crook Streets.</p> <p>The house is a Colonial Revival clapboard covered frame structure, two and a half stories high, with a symmetrical facade (east side) of three bays, a hip roof with large dormers, a two and a half story bay window on the south side, and a one story frame porch across the front. The main centered entranceway has double doors and is flanked by two large windows. The second story has three large windows. The principal windows have double-hung wooden sashes with one-over-one lights. The facade windows have louvered shutters.</p> <p>The house is structurally sound and the exterior is basically unaltered since construction.</p>




