This building is a 2 storey plus attic frame structure that has been covered with asphalt shingles. Rectangular in plan, the gable end faces the street (Oak Street). The most prominent feature is the two storey porch which supports the shingled and bracketed gable end. Ground floor of porch has been closed in for window display space.

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

Most of this building is obscured by modern siding, etc., but it is hardly an outstanding structure. It does have some Eastlake-type, 1870s Victorian commercial decoration. This decoration, and the double front porch are somewhat reminiscent of the now demolished Friendsville Store (G-3). Noteworthy features of this store are the 2nd storey with its brackets, and the crenellation-like shingles and 'barge-board' on the pediment.






4. NOTABLE FEATURES, HISTORICAL SIGNIFICANCE AND DESCRIPTION OPEN TO PUBLIC **YES**
