DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

3 Wilson Street is a 2 storey plus attice clapboard house, rather larger than most of its neighbors. The plan is somewhat cross shaped with two gabled roofs intersecting each other. There is some elaborate decorative treatment, but it is confined to the east and south-east sides of the house. The entrance, for example, is on the south-east where two wings intersect; the entrance porch thus formed is a double storey, semi-hexagonal affair, braced with jig-saw cutouts. Three of the [4] end gables have barge-boards, plus a corss-shaped truss-like support, as well as fish-scale shingles at attic level. There are simple brackets supporting the overhanging roof. The east gable end has a 2 storey bay window with some stained glass. A 'contemporary' bay window has been punched through the gable end on the south.

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

3 Wilson Street is the type of house that almost every average-sized 'middle American' town has at least one of [it is often the funeral home]. By national standards, this Oakland example is not that elaborate, but it must have been one of the town's more substantial residences when it was built. It is picturesque in its slightly unusual entrance-way and in its orientation, and, though not TOTALLY INTACT, the bargeboards are examples of the stock, machine-made ones produced after hand made ones went out.

[The present owners have long association with Oakland. Father of Paul Naylor was A.D. Naylor -- see G-16 -- and his nephew presently owns the A.D. Naylor Building; Rolyans is also a Naylor owned business].



3 Wilson Street is a 2 story plus attic clapboard house, rather larger than most of its neighbors. The plan is a somewhat cross shape with two gabled wings intersecting @ other.

~~Most~~ There is some elaborate decorative treatment, but it is confined to the east + south east sides of the house, the entrance, for example is on the s-e ~~between the two~~ where 2 wings intersect - forming a semi-hexagonal double story porch, braced w/ gig saw cut work.

3 of the end gables have barge boards + a cross-shaped truss-like affair, plus fish scale shingling (under the eaves) at attic level. The end gable end has a 2 story bay window w/ some stained glass.

There are simple brackets under the supporting the roof overhang. A 'modern-day' bay window has been punched into the end of south wing.
