Justification for decision: (Use continuation sheet if necessary and attach map)

The Old Deer Park Road Segment is recommended not eligible for the National Register. Although probably documenting road networks during the Oakland area's period of most significant growth, the road and bridge possess insufficient integrity of materials, workmanship, design, association, and feeling. Research has not identified any significant associations with historic persons or events. The road and bridge neither reflect the distinctive characteristics of a particular architectural style nor embody the representative work of a master craftsman or method of construction. The road and bridge also do not appear to potentially provide important information for the study of history.

This segment of Old Deer Park Road (G-VI-A-069) consists of an approximately 30 meter (100 feet) section of abandoned macadam road surface and an old concrete-slab bridge south of and parallel to the Memorial Drive between North Fourth Street and Pythian Drive.

The Deer Park Road was probably laid out and cleared during the late 1870s in response to the establishment of resort hotels in Oakland and Deer Park in 1875 and 1873 respectively. The road surface and bridge help to document the impact the Oakland area's subsequent development.

This segment of Old Deer Park Road (G-VI-A-069) consists of an approximately 30 meter (100 feet) section of abandoned macadam road surface and an old concrete-slab bridge south of and parallel to the Memorial Drive between North Fourth Street and Pythian Drive. Memorial Drive, constructed on a high fill section roughly 10 meters (30 feet) above the earlier road surface, replaced the Old Deer Park Road alignment sometime after 1948. A USGS quadrangle map for Oakland from that year depicts the earlier Deer Park Road alignment.

The road surface extends in a primarily west to east direction and is about three meters (10 feet) wide. The concrete slab bridge stands at the eastern end of the macadam section and carried the road over a tributary of Wilson Creek that flowed in a generally southerly direction towards Oakland. The creek has been rerouted a short distance to the east since the road segment has been abandoned.

Road networks in Garrett County did not become somewhat extensive until after the construction of the Baltimore & Ohio Railroad (B&O) in 1851 and the B&O's subsequent promotion of the region as a summer vacation resort beginning in the 1870s. Both Deer Park, located a few miles east of Oakland along the B&O, and Oakland experienced extended periods of relatively intense growth and development as a result of the B&O's establishment of resort hotels in the two communities. The Deer Park Road was probably laid out and cleared by the late 1870s in order to ease the movement of people between the two resort towns. Although the resorts at Deer Park closed during the early twentieth century, the road probably continued to serve the surrounding area carrying traffic to Oakland, installed as the county seat in 1873 and the region's primary market town. This segment of roadway was probably abandoned sometime after 1948 upon completion of Memorial Drive.



