The Dorris and Carolyn Updyke House is recommended not eligible for the National Register. Although illustrative of settlement patterns in the Oakland area during the mid-twentieth century, the dwelling possesses poor integrity of materials, design, workmanship, feeling, and association. Research has not identified any significant associations with historic persons or events. The house neither reflects the distinctive characteristics of a particular architectural style nor embodies the representative work of a master craftsman or method of construction. The building also does not appear to potentially provide important information for the study of history.

The Dorris and Carolyn Updyke House is located at 624 South Third Street in Oakland. The mid-twentieth-century one-and-one-half-story brick cottage is three bays wide and two bays deep.

Erected in 1945 according to Garrett County tax records, the Dorris and Carolyn Updyke House reflects the settlement of residential areas in prior open land adjacent to Oakland in the mid-twentieth century.

The Dorris and Carolyn Updyke House (# G-VI-A-041) is located at 624 South Third Street in Oakland. The mid-twentieth-century one-and-one-half-story brick cottage is three bays wide and two bays deep. The house is surrounded on three sides by a modern one-story frame addition. An projecting gable entrance dominates the front elevation. Facing northwest, the dwelling sits on a flat square lot in a subdivision of similar homes along Third Street.

The dwelling is constructed of red brick laid in running bond and rests on a concrete block foundation that encloses a full cellar. It has a steeply-pitched side-facing gable roof with a centrally-placed projecting gable front entrance. There are two gable-roofed inset dormers on the front elevation and a half-width central gable-roofed dormer on the rear elevation. The roof is sheathed in asphalt shingles and finished with a shallow box cornice covered with vinyl. The windows have been replaced with one-over-one vinyl double-hung sash. The front entrance has a paneled wood door with a row of arched lights. Flat vinyl molding surrounds the door and window openings. An exterior brick chimney with a gabled metal hood is located on the northeast (side) elevation.

The original house is surrounded on its two sides and rear by a frame one-story addition, which include a two-car garage off the northeast elevation. This addition has a side-facing asphalt-shingled gable roof finished with a box cornice and wide eaves clad in vinyl. It is clad in vinyl siding and rests on a concrete block foundation. Fenestration in the addition consists of one-over-one vinyl double-hung sash. Many are in bands or pairs. There are two rear entrances on the southeast (rear) elevation of the addition. A second brick chimney rises above the rear roof of the addition.

The back yard is defined by rows of tall evergreen trees. A one-story prefab plywood shed with a gambrel roof is located behind the eastern rear corner of the house. A macadam drive leads from the street to the garage.

The Dorris and Carolyn Updyke House, erected in 1945 according to Garrett County tax records, reflects the settlement of residential areas in prior open land adjacent to Oakland in the mid-twentieth century. Area landowners subdivided parcels along much of South Third Street, then part of the Garrett Highway (US 219's predecessor) and the principal road network leading south of town, during the 1940s. An example of settlement radiating outward from village and town centers along established road networks, development of the South Third Street area evolved during this period in response to Oakland's continuing role as the county's seat of government and the principal market town for southern Garrett County. Oakland annexed the South Third Street area into its corporate limits in 1989.




